

GENERAL POWER OF ATTORNEY

Know by all men that I, _____ s/o, d/o, w/o
_____ presently residing at _____
(local address) holder of Indian Passport No. _____ dated _____ issued at
_____ do hereby appoint _____
as attorney for me and in my name to do and execute all or any of the following acts,
deeds and things, that is to any :

1. To demand, issue for, enforce payment of, receive and give discharge for all my money, securities for money, debts, stocks, shares, gold and other personal estate now belonging to herein after to belonging to me (whether solely or jointly with any other person or persons.)
2. To commence, carry on, defend all actions and other proceedings/touching my estate or any part thereof, or touching anything in which I or my estate may be in anyway concerned.
3. To settle, comprise or submit to arbitration all accounts, claims and disputes between me and any other person or persons.
4. To invest any of my moneys in such manner, at such rate of interest and upon such securities as my attorney shall in his absolute discretion think fit, and from time to time vary the said investments or any such investments as aforesaid to deposit the said moneys or any part thereof with any banker or bankers to whom my attorney shall think fit to entrust the same.
5. To accept the transfer of any stocks, funds, shares, annuities and other securities which shall or may at any time hereafter be transformed to me whether solely or jointly as aforesaid.
6. Out of such moneys to pay such calls upon shares, or other expenses in respect of any part of my said estate as my attorney shall think fit an to receive the dividends, interests and income arising from any stocks, shares or other estate now or hereafter belonging to me (whether solely or jointly as aforesaid).
7. To vote at the meeting of any company or companies, or otherwise to act as my attorney or in respect of any stocks, shares or other investments now held or which may thereafter be acquires by me therein (whether solely or jointly as aforesaid).
8. To carry into effect and perform agreements entered into by, me with any other person.
9. For the purpose aforesaid or any of them enclose and sign my name to any cheque, dividend or interest warrants or other instruments payable to me (whether solely or jointly with any other person or person) and to sign my name and executes, transfers, assignments, deeds and instruments whatsoever.

10. To concur in doing any of the acts and things herein before mentioned in conjunction with any other person or persons interested in the premises.
11. To appoint and remove at pleasure any substitute for or agent under him in respect of all or any of the matters aforesaid upon such terms as my attorney shall fit.
12. Generally to act relation to my estate and to the premises as fully and effectually in all respects as I myself could do.

And I hereby undertake to ratify everything which my attorney or any substitute of agent or agents appointed by him under the power in that behalf herein before contained shall do or cause to be done and to indemnify them in virtue of these presents.
